Background on SB 854

Before

 UC already subject to Prevailing Wage requirements

After

- Added administrative requirements that will affect Procurement
- Expanded definition of "public works" for which prevailing wage must be paid

Prevailing Wage

State of California

The Department of Industrial Relations (DIR) sets Prevailing Wage according to the type of work and location

All workers employed on public works projects must be paid the prevailing wage



Definition of Public Works

construction



repair work



alteration



demolition



installation



maintenance

Paid for in whole or part with public funds and done under contract. Generally does not apply to work done by UC employees

Definition of Public Works

 For federally funded construction, whichever is most stringent applies

Federal law



California Law (SB 854)



When Are Prevailing Wages Required?

All public works over \$1,000 including maintenance












When Are Prevailing Wages Required?

If there are **ANY** public funds in a public works project, the whole project is subject to prevailing wage requirements

Public funds includes self-supporting departments where revenue is not derived from state funds:






Transportation, parking



Auxiliary business services



Prevailing Wage Decision Tree



Exception 1: Janitorial or custodial services of a routine, recurring or usual nature

Exception 2: Protection of the sort provided by guards, watchmen, or other security forces

Exception 3: Landscape maintenance work by "sheltered workshops," where "sheltered workshops" are nonprofit organizations licensed by the Chief of DLSE employing mentally and/or physically handicapped workers

Categories of Public Works

Construction






Renewable energy projects



Hauling of refuse





Maintenance done under contract and paid for in whole or part with public funds

Maintenance now includes projects not previously covered by Prevailing Wage requirements

Prevailing Wage Commodities Lis

Samples of Contracted Maintenance Work	Must Pay Prevailing Wages? (If >\$1,000)
Tree trimming	yes
Landscaping Maintenance	yes
Equipment Repairs (pumps, motors, belts, etc.)	yes
Elevator Maintenance	yes
Roofing, Patch	yes
Drop Ceiling Repair	yes
Carpet replacement	yes
Installation of Modular Furniture	yes
Painting, touchup	yes



Hauling of Refuse

- From a public works site to an outside disposal location
- Does not include hauling of recyclable materials separated from jobsite to be sold at fair market value







Done under private contract where the work is performed on UC property in California

- and -

more than 50% of the energy generated will be purchased by UC

- *or* -

the project is primarily intended to reduce UC's energy costs

Risks of Non-compliance?



If UC does not require its suppliers to pay prevailing wages when applicable:

- Contract subject to cancellation
- Reputation risk
- Supplier could be fined or debarred from public works projects
- Supplier could sue UC for any increased costs including:
 - labor cost increases and penalties
 - attorney's fees

New Requirements - UC Must:

When *requesting* quotes, or bids:

- Notify suppliers of registration requirement with DIR
- 2. Specify that project is subject to compliance monitoring/enforcement by DIR
- 3. Require the prime contractor to post job site notices as prescribed by regulation
- 4. Require all suppliers on public works projects to provide proof of DIR registration

What Must UC Buyers Do?



- Before awarding a contract, confirm supplier's DIR registration by searching DIR's database
 - Yes, this is *in addition* to requiring supplier to provide proof of registration
 - DIR has a database of all registered suppliers

<u>Do not accept bid</u>, enter a requisition, or enter into a contract without proof of supplier's DIR registration

What Must UC Buyers Do?

If someone reports a suspected prevailing wage violation



Take action!

- Report the suspected violation to DIR
- Campus can investigate allegations (if it has an infrastructure to do so)
 - e.g. UC Davis


